




Youth Champs 2026 will take place in one of Birmingham's most distinguished educational settings – King Edward's School.

It is essential that you complete the relevant forms and submit them to us on your arrival at Youth Champs 2026.

On arrival, please send a representative of the band to the registration desk (also known as Contest Control) to check into the event. Registration is in the Dining Hall, which is in a separate building to the two performance spaces. There will be signs to direct you. See the venue map on p17.

Please ensure your lead contact brings hard copies of the following documents:

- Stage plan x 2 copies to be submitted on arrival
- Safeguarding Consent Form BOPA (organisation) – to be submitted on arrival
- Safeguarding Consent Forms BOPA (individual) – to be retained by the band

General Sale

Tickets will be available for general sale from the <u>Youth Champs</u> <u>ticket page</u> on BBE website starting Monday 23 February 2026.

Advance tickets offer the best value, and help supporters avoid queues and potential disappointment on the day. Pre-purchased tickets can be collected from the ticket desks located within the foyers of each performance hall.

Psst, earn back your band's entry fee with the Ticket Boost scheme!

That's right – entry to Youth Champs can cost your band nothing with BBE's early bird Ticket Boost Scheme. Here's how it works:

- 1. Your band orders up to 50 Youth Champs tickets with a £1 discount each
- 2. Your band sells these tickets onto parents and supporters at the lower advance price
- 3. You keep the £50 savings helping to cover your band's £50 entry fee (BBE Member Band rate) for the event

The Ticket Boost Scheme is the easiest, fastest way to let families and supporters know about the event, while giving them a discount on on-the-door prices. More than just a fundraiser, you'll fill the hall with your most loyal fans! If you prefer, you can pass the £1 saving directly to your supporters instead.

Bands that are not BBE Members can still take part in the scheme and receive up to £50 in savings per Section entry. If your organisation has more than one band performing, or you're entering more than one Section, the maximum discount increases (for example, £100 for two sections or two bands).

How to order from the Ticket Boost scheme:

- Use your <u>band order form</u> to request discounted tickets
- Submit your ticket order by 9am on Friday 30 January 2026
- Once payment is received (we'll send you an invoice), your tickets/wristbands will be posted to you ahead of the event

You can use the order form more than once if you need to place additional orders, but the total discount per band or section will remain capped.

Please check your band's scheduled arrival and performance times carefully below. The running order within each group was determined by a draw, based on each band's proximity to the venue, to ensure fairness for all performers.

We recommend... arriving well in advance to ensure your band is settled and not rushed prior to their performance. Allow extra time for travel delays. While you wait, you'll have the unique chance to listen to and learn from some of the UK's very best youth bands – at no extra cost! It's a fantastic way to pick up tips before your own performance, or relax and enjoy the music afterwards. Also take the opportunity to explore the venue, visit trade stands and meet your Section sponsors.

ARRIVAL AND REGISTATION

Once your group has arrived on site and gathered together, please make your way to the Dining Hall. We ask that one responsible adult comes to the registration desk to hand over your key documents, including safeguarding forms and stage plans.

A member of the BBE team will then run through essential event information, such as the locations of child-only toilets, our fire evacuation procedure and our lost-child process. Wristbands will be issued at this point – performers and chaperones will each receive different colours for easy identification.

After registration, you will be introduced to your designated band guide, who will take you to your allocated classroom. This will be your group's base whilst you are in the contest system. You can leave belongings here before moving on to your warm-up room and then to the performance stage.

We respectfully ask that you please arrive at your designated arrival time, not prior. If you arrive earlier, your band's waiting area may not yet be available.





Transport and parking

Coach

If your band is travelling by coach, please enter the site through the main gates on Edgbaston Park Road (postcode: B15 2UA). Once inside, you will find a designated coach drop-off point and a turning loop. This area is for drop-off and pick-up only — coaches cannot remain parked on site.

Please ensure your coach driver moves to an approved coach parking area within Birmingham after drop-off.



Public transport

Where possible, we are asking our audiences to arrive by train. University (Birmingham) Station is a 15-minute walk from King Edward's School. Once you've arrived at the railway station, head down Westgate and University Road West, walking past the University of Birmingham Law School. Take a right onto Edgbaston Park Road then left again at Bristol Road. The school is located through the gates.

The venue is next to the Bristol Road, with bus stops for major bus routes both in and out of Birmingham city centre: 63, 144, 886, X61.

Car

Challenge and Championship Sections

Please use the Parade Ground Car Park - access is through a school entrance on the Bristol Road (A38), via Park Vale Drive Gate (postcode: B5 7SP).

Showcase and Performance Sections

Please use the Girls' School Car Park via Edgbaston Park Road. Enter through the main gate of King Edward VI High School for Girls (KEHS) (postcode: B15 2UB).

Overflow parking

If these car parks are full, please proceed directly to the overflow car park at the Lloyds Bank Grounds on Bristol Road, just to the left of the turn onto Eastern Road (postcode: B29 7LG). You can then enter the site on foot via Vince Gate, next to the Sports Hall.

GETTING AROUND THE VENUE

A dedicated band guide will stay with your group throughout your entire journey within the contest system.

After meeting you at the registration desk, they will lead you to your designated classroom to drop off belongings, then on to your warm-up room, the side of the stage for your performance, your professional photography session, and finally back to your classroom to collect your items.

Please be aware that the system has changed from previous years: there is no central waiting area (previously in a sports hall) this year, so movement between spaces will be more direct, with your band guide supporting you at every step.

Wristbands

Wristbands will be issued on arrival. Please ensure all performers and supervising adults wear the correct wristband at all times.

Wristband colours:

- Navy blue Performer
- Yellow Performer with no photography consent
- Magenta DBS-checked chaperone
- White Additional adult helper (not a chaperone)

Valuables

At check-in, a valuables box will be provided for a responsible adult to collect items such as phones and wallets from performers. This box should stay with the group as you move through the contest system.

<u>Any valuables left in your classroom are done so at your own risk</u>. Brass Bands England cannot accept responsibility for lost or stolen items. While every effort is made to keep classrooms secure, we cannot guarantee that others will not enter these rooms while you are away.

PLANNING YOUR DAY

Accessibility

The site is fully accessible. However, if any of your performers/support team/audience members have accessibility needs, please contact youthchamps@bbe.org.uk as soon as possible to ensure you get the appropriate help you need on the day.

Additional social spaces

The **Dining Hall**, located centrally within the school grounds, has been designated as a social space for this year's event. Please use this space if you'd like a seat/to eat food/to gather your band and supporters whilst on site. Please note, this room will not be staffed by BBE so young people must only enter if chaperoned by an adult.



The Youth Champs Box Offices will be located in the foyers of each performance hall - one in The Ruddock Hall and one in the Girls' School Hall foyer. At either desk, you can purchase tickets or collect any pre-ordered tickets.

Trade stands

Both foyers will also host a variety of trade stands, featuring everything from instrument manufacturers and sheet-music publishers to armed forces representatives and uniform suppliers.

You'll also find the BBE merchandise stalls where official Youth Champs items - including t-shirts and teddy bears - will be available to purchase.

Catering

A selection of food vans will be on site throughout the day, offering a wide variety of options including hot meals, lighter snacks, sweet treats, tea, coffee and soft drinks. Options will include vegetarian and vegan choices, and we have asked all vendors to clearly display allergen information so you can make informed choices. As each trader operates independently, some may only accept card while others may only accept cash, so please ensure you bring both payment methods with you.

Food and drinks can be enjoyed in the Dining Hall, where ample seating will be available for bands, families and supporters. We kindly ask that everyone helps us keep this shared space clean by wiping down tables where needed and disposing of any rubbish in the bins provided. You are also welcome to bring your own packed lunch or snacks if that suits your schedule or dietary needs better.


YOUR ADJUDICACTORS

Each Youth Champs section will have two adjudicators who will sit centrally in the hall and listen to every performance. They will be able to see each band clearly and will provide written feedback using laptops while viewing your digitally uploaded scores on a second device. All adjudicators were appointed through an open callout and selected for both their alignment with the ethos of Youth Champs and their proven contribution to the brass band sector.

In the new year, you will receive a link to your band's private Google Drive folder. Here, you must upload digital scans of your scores by the **9 March deadline**, along with your stage plan (a draft template can be found at the end of this document). You can also use this folder to notify us of any performers who cannot be photographed. Your folder is unique to your organisation, and only authorised BBE team members will have access.

When uploading your scores, please ensure all pages are the correct way up, clearly legible, and complete - no missing bars or cut-off staves. If you are making cuts to any piece, these must be clearly marked.

For compere notes, you can choose whether our compere simply introduces your band on stage or supports your full performance. Guidance on preparing compere notes can be found <u>here</u>.



LEGAL REQUIREMENTS

To comply with current legislation regarding Child Performance Licensing, Brass Bands England holds a Body of Persons Approval (BOPA) licence from the Secretary of State for Education. This means your band will not need to apply for any additional Child Performance Licences to partake in Youth Champs.

To comply with this BOPA, and as a condition of entry, you must complete the following (text in bold provides further clarification from the application form):

- 1. Provide an appropriate number of supervising adults to care for children.

 Supervisors must have had a DBS check or DBS Status check within the last three years, verified by the organisation. Supervisors are acting in loco parentis and must be capable to exercise control of the child and provide the care which a good parent might be reasonably expected to give to that child. Children must be kept within sight or sound of the supervisor at all times ideally both.
 - The maximum number of children per supervising adult is 12. However, you should provide more than one adult to every 12 children so that the ratio of 1:12 can be maintained even if an adult becomes unavailable.
 - If a DBS check raises any concerns, a risk assessment must be completed before the adult is permitted to work with children, and this must include consultation with Brass Bands England. As licensees, we require this consultation to ensure an adequate risk assessment has been carried out.
- 2. Sign your organisation in and out at Band Registration located in the Dining Hall.

- 3. Ensure written participatory permission, photographic consent, emergency medical information and contact details for next of kin are available for all child performers at the place of performance.
 - We have provided a template Safeguarding Consent Form* to collect the
 information you need for each individual child. Please ensure you have this
 information available for each child on the day. You may use the template
 provided or collect the information via another method.
- 4. Ensure no child receives any payment for their performance except for defraying expenses.
- 5. Ensure suitable arrangements are made for children to get home, or to another approved destination, after their last performance.
- 6. There will be child-only toilets which will be clearly labelled in close proximity to your band waiting room. There are more toilets available throughout the site, however they will not be child-only. Should your children use non-child only toilets, they should be chaperoned by a band supervisor.

LEGAL REQUIREMENTS

As a condition of entry, your band must comply with the requirements outlined in this pack, including providing sufficient DBS-checked supervising adults, maintaining the 1:12 supervision ratio, and ensuring that written participatory permission, photographic consent, and emergency contact details are available for all child performers. Child-only toilets must be used where indicated, and children must be supervised at all times.

Please note: if these safeguarding requirements and associated permissions are not submitted and in place, your band will be denied a performance at Youth Champs, as this would constitute non-compliance with the terms of our BOPA. Ensuring these measures are in place protects both your performers and the wider event, and is essential for participation.

PHOTOGRAPHIC CONSENT

At Youth Champs, official photographers/videographers and event staff capture images and footage of bands performing throughout the day. These materials will be used by Brass Bands England across our website and marketing materials to publicise future Youth Champs events and other BBE activities.

It is important that every band obtains permission for young participants to be photographed or filmed, and that all parties understand how these images may be used.

Participating bands must inform all parents/carers that photography and filming will be taking place at Youth Champs, explain the purpose clearly, and obtain their written permission via the Safeguarding Consent Forms (included below). This is for your own records - you only need to let BBE know which children cannot be photographed.



Important Actions

- Please email <u>youthchamps@bbe.org.uk</u> with the name of any child who cannot be photographed as early as possible, and include the instrument they play.
- When submitting your stage plan, please highlight where this child will be positioned within the band so we can pass this information on to the official photographers/videographers and event staff.

Any young people who cannot be photographed, as indicated by the information you provide to us, will be issued with a different-coloured wristband so that official photographers/videographers and event staff know not to take photos.

To ensure smooth running on the day, we ask you to provide names and instruments of nophoto children in good time before the event. This also allows us to better brief our staff so as to minimise the risk of accidental capture.

Please remember that parents/carers may have their own reasons for not wanting their children to be photographed or filmed, and it is important to respect this.

Audience photography

The audience will also be informed not to:

- Take photos or film anyone they do not have permission to capture
- Take photos or film during performances

However, as a public performance, this is almost impossible to police and Brass Bands England cannot take responsibility for compliance.



FORMS AND CHECKLISTS

As outlined earlier in this pack, BBE will be applying for a Child Performance Licence for Youth Champs 2026 under our organisational BOPA. To meet the legal requirements of this licence, each band must complete the Organisational Safeguarding Consent Form (further down this pack) and hand it in at band registration upon arrival.

At registration, you will also be asked to confirm that you hold an individual Safeguarding Consent Form for every performer, containing their emergency contact details, relevant medical information and photography consent. An example template is included below for your convenience, though you are welcome to use your own template if preferred.

Please note: we do not need to see the individual forms, but you will be required to declare that these are complete and available within your band's safeguarding records.

Player checklist

A final Player Checklist form will be sent to you digitally in early March, for submission prior to the event. You will be asked to provide a list of all (including any adult helpers) participating performers in your band, including their age and date of birth.

Stage space allows for a **maximum of 55 players** per band. For safety and fairness, we cannot exceed this limit under any circumstances



Ensure written participatory permission, photographic consent, emergency medical information and contact details for next of performance. We have provided a template Safeguarding Consent Form* to collect the information you need for each child. Please ensure you may use the template provided or collect the information via another method. Ensure no child receives any payment for their performance except for defraying expenses. 

Results and trophies

For the results ceremony, please ensure that at least one representative from your band is present to collect your certificate. Every band will receive a Certificate of Participation, and bands in the Performance, Challenge and Championship Sections will also receive a Merit–Gold Award.

If your band is awarded one of our glass trophies, these are yours to keep. If you are presented with a silver trophy, you will be required to sign a form confirming that you will:

- keep the trophy in good condition,
- arrange for it to be engraved, and
- return it to us in time for next year's event.

This year, all adjudicator remarks are delivered digitally and will be emailed to you the week following the contest. You will also be sent a feedback form to compete about your experience of the event and any improvements we can make for future years.

Photography purchasing

For your professional photographs, Rapps Photography will contact you directly with purchase details. They will provide a unique access code for safeguarding purposes, which you can share with parents so that only they can view and order images of their own child.

Lost property
